Given certain issues where our health may be compromised, closing the doors seems the best course of action.


Physically, the closure is acceptable - but how about spiritually? I miss the prayer, the music and the camaraderie of our congregant friends.




These photos as a reminder of what was - and what will be as soon as it is safe to worship again.

## United Way in state aids those in hardship during pandemic

SHELTON - The COVID-19 health crisis has required philanthropy to respond differently than traditional approaches.

Nonprofits and funders alike knew families that lost their income and resources and were not accustomed to looking for charitable resources.

Through the <u>Connecticut United Ways COVID-19 Response Fund</u>, payments are being distributed to residents across the state in need.

For the first round of distribution, the Fund raised \$450,000 to help Connecticut residents facing immediate financial hardship. Donors for that first round include:

- The Aetna Foundation
- The Connecticut Health Foundation
- Travelers Insurance
- Webster Bank
- Newtown Savings Bank.

Since then, an additional \$160,000 has been raised.

Valley United Way is currently working with TEAM, Inc. in Derby to identify those most in need. Initially, recipients will receive \$200 with additional funds may be available as donations allow.

With almost \$13,000 funds raised for the Valley to date, over 60 families have already started to receive funds to help with their most pressing needs.

Through a partnership with EML Payments Limited ("EML"), the innovative collaboration allows rapid distribution of dollars directly to beneficiaries.

Once a beneficiary is pre-qualified by TEAM, funds are loaded into a mobile wallet on the beneficiary's smartphone. The funds are used to pay for necessities, such as food, medicine, utilities, and gasoline.

The electronic distribution allows monies to be given to those who need it most, without violating social distancing requirements. This model of expedited delivery gives families the flexibility to address their most urgent needs.

"Valley United Way is grateful for its partnership with the staff of TEAM to bring this state-of-the-art resource to the Valley right now. We knew that so many businesses were going to be closed, we knew we had to work quickly and smartly to help people," said David Kennedy, Interim President. "Thanks to compassionate donors who treasure system work, we are able to get funds directly to those who need it most."

Non-profit leaders who have been overwhelmed with requests since the crisis began were grateful to be able to offer relief to those in need.
